**AN ORDINANCE OF THE BOROUGH OF RARITAN,
SOMERSET COUNTY, NEW JERSEY AMENDING
CHAPTER 82 OF THE CODE OF THE BOROUGH OF
RARITAN**

Statement of Purpose

The purpose of this ordinance is to provide an accessible parking space at 20 Anderson Street

WHEREAS, residents of the Borough have shown interest in having an accessible parking space near 20 Anderson Street.

WHEREAS, it is beneficial for the Borough to provide parking spaces to persons of all abilities.

NOW, THEREFORE, BE IT ORDAINED by Mayor & Council of the Borough of Raritan:

SECTION 1: The following sections be added to Chapter 82 Vehicles and Traffic, Part 4 Handicapped Parking:

82-71.1.D(17)

20 Anderson Street. The handicapped parking space shall be located on the east side beginning at a point, on Anderson Street, located 29' north of a line drawn made from the northly curblineline of 1st Street and extended to the easterly curblineline of Anderson Street and extending 22' north from said point.

SECTION 2: Severability. Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent subsection, sentence, clause and phrase, and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

SECTION 3: Repealer. Should there exist any inconsistency with other ordinances of the Borough, or should any provision of this ordinance be inconsistent with the provisions of any other prior ordinances, the inconsistent provisions of such other prior ordinance are hereby repealed, but only to the extent of such inconsistencies.

SECTION 4: Purpose of Captions. The captions contained in this Ordinance have been inserted only for the purpose of facilitation reference to the various sections, and are not intended and shall not be utilized to construe the intent and meaning of the text of any section.

SECTION 5: Effective Date. This Ordinance shall take effect after adoption, passage, and signature by the Mayor in accordance with N.J.S.A. §40A:60-5(d).
