ORDINANCE NO. 2025-05

AN ORDINANCE OF THE BOROUGH OF RARITAN, SOMERSET COUNTY, NEW JERSEY AMENDING CHAPTER 320 “STREETS AND SIDEWALKS”, ARTICLE IV, “STREET OPENINGS”

WHEREAS, the Governing Body of the Borough of Raritan, County of Somerset, State of New Jersey finds it necessary to adjust street opening fees to reflect current costs; and

WHEREAS, the current street opening fee of \$30 has been determined to be insufficient to cover operational expenses.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Raritan, County of Somerset, State of New Jersey as follows:

SECTION 1. AMENDMENT TO FEE SCHEDULE

Chapter 320, Article IV, Section 26, “Fee, Performance guaranty” is hereby amended to read as follows:

The applicant shall pay to the Borough Clerk an application fee of \$150 and shall deposit with the Borough Clerk, either in cash or check, an amount determined by the Engineer to be sufficient to guarantee performance by the applicant under this article, based upon the estimated cost of the work to be done under the application.

SECTION 2. REPEALER

All ordinances or parts of ordinances inconsistent with this amendment are hereby repealed to the extent of such inconsistency.

SECTION 3. SEVERABILITY

If any section, subsection, sentence, clause, or phrase of this ordinance is held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance.

SECTION 4. EFFECTIVE DATE

This ordinance shall take effect upon final passage and publication as required by law.




