ORDINANCE NO. 2025-09

AN ORDINANCE OF THE BOROUGH OF RARITAN, SOMERSET COUNTY, NEW JERSEY AMENDING CHAPTER 82, “VEHICLES AND TRAFFIC”, SECTION 46.1, “UNATTENDED DUMPSTERS AND CONTAINERS”

WHEREAS, the Governing Body of the Borough of Raritan, County of Somerset, State of New Jersey finds it necessary to amend the existing Borough Code related to dumpsters and containers to insert a fee; and

WHEREAS, the current ordinance does not contain a fee;

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Raritan, County of Somerset, State of New Jersey as follows:

SECTION 1. AMENDMENT TO FEE SCHEDULE

Chapter 82, Section 46.1, is hereby amended to include a new subsection, Part C, to read as follows:

C. No person shall place an unattended dumpster or container on a roadway in the Borough without first receiving written approval from the Borough. All applications shall include a fee of \$50 for dumpsters of 20 yards or fewer and \$100 for those exceeding 20 yards.

SECTION 2. REPEALER

All ordinances or parts of ordinances inconsistent with this amendment are hereby repealed to the extent of such inconsistency.

SECTION 3. SEVERABILITY

If any section, subsection, sentence, clause, or phrase of this ordinance is held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance.

SECTION 4. EFFECTIVE DATE

This ordinance shall take effect upon final passage and publication as required by law.
