

BOROUGH OF RARITAN
ORDINANCE NO. 2025-15

RENAMING SECTION 82-82.3 OF CHAPTER 82 – VEHICLES AND TRAFFIC – PRESENTLY ENTITLED “THROUGH STREETS; STOP AND YIELD INTERSECTIONS; NO RIGHT TURNS” TO “THROUGH STREETS; STOP AND YIELD INTERSECTIONS; CERTAIN TURNS PROHIBITED,” AND AMENDING AND SUPPLEMENTING SAME TO CREATE PARAGRAPH D. THEREIN TO PROHIBIT LEFT TURNS ONTO CERTAIN MUNICIPAL STREETS

WHEREAS, the Borough Council of the Borough of Raritan, County of Somerset, State of New Jersey wishes to prohibit the public from making left-handed turns on certain municipal streets; and

WHEREAS, presently, Section 82-82.3 – Through Streets; Stop and Yield Intersections; No Right Turns – only prohibits right-handed turns; and

WHEREAS, the Borough Council believes that amending the aforementioned Section and renaming same to “Through Streets; Stop and Yield Intersections; Certain Turns Prohibited” is in the best interest of the Borough and its residents; and

WHEREAS, the implementation of these prohibitions and the common-sense approach to the naming of the Section will make the Borough Code more user friendly streamlined.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Raritan, County of Somerset, State of New Jersey that Section 82-82.3, presently entitled “Through Streets; Stop and Yield Intersections; No Right Turns” be renamed to “Through Streets; Stop and Yield Intersections; Certain Turns Prohibited” and that Section 82-82.3 be amended and supplemented by the creation of Paragraph D, prohibiting certain left-handed turns, as follows:

SECTION I:

Additions to this Section shall be delineated by underlined text, thusly.

Deletions to this Section shall be delineated by strikethrough text, ~~thusly~~.

§ 82-82.3. Through Streets; Stop and Yield Intersections; ~~No Right~~ Certain Turns Prohibited.

A. [. . .]

D. Left turns from Fifth Street onto First Avenue are prohibited. Left turns from Tillman Street onto First Avenue are also prohibited.

SECTION II:

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

SECTION III:

If any article, section, subsection, paragraph, phrase or sentence of this ordinance is, for any reason, declared to be unconstitutional or invalid, such article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

SECTION IV:

This ordinance shall take effect immediately upon final publication as provided by law.


