ORDINANCE NO. 2025-17

AN ORDINANCE OF THE BOROUGH OF RARITAN, COUNTY OF SOMERSET, STATE OF NEW JERSEY AMENDING SECTIONS 82-55 AND 82:57 OF CHAPTER 82 – VEHICLES AND TRAFFIC

WHEREAS, the Borough Council of the Borough of Raritan, County of Somerset, State of New Jersey wishes to increase the fees associated with parking in the NJ Transit commuter lot in the Borough of Raritan, as well as permitted days and times; and

WHEREAS, the Borough Council believes that amending the aforementioned Sections is necessary to update the days, times, and rates, which have not been adjusted since 2007.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Raritan, County of Somerset, State of New Jersey:

Section 82-55 shall now read as follows:

The fee for obtaining one commuter monthly parking permit at the Raritan Railroad Station shall be \$60 per month. The fee for daily parking shall be \$4 per day.

Section 82:57 shall now read as follows:

It shall be unlawful for any person to cause, allow, permit or suffer any vehicle registered in the name of or operated by such person to be parked in any parking area designated in this article between the hours of 4:00 a.m. and 8:00 p.m., seven days per week, except legal holidays, without having paid for a permit.

SECTION 1:

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed to the extent of such inconsistencies.

SECTION II:

If any article, section, subsection, paragraph, phrase or sentence of this ordinance is, for any reason, declared to be unconstitutional or invalid, such article, section, subsection, paragraph, phrase or sentence shall be deemed severable.

SECTION III:

This ordinance shall take effect immediately upon final publication as provided by law.






